

# SHIPPER'S INDEMNITY AND ACKNOWLEDGMENT

I \_\_\_\_\_ being the owner of the animal/s listed in the attached Air Waybill (Animal), declare that, in respect of each Animal:

- it is my responsibility to determine whether the Animal is suitable to travel on the journey for which I am lodging the Animal for carriage; and
- I am not aware of any reason that the Animal should not undertake the intended journey, such as ill-health or aggressive behaviour that may put the Animal or others in danger; and
- I will comply with all applicable laws, including Government Quarantine Regulations which govern the importation and exportation of animals; and
- I will ensure that the Animal's cage or transportation container complies with all regulatory requirements and requirements of the Airline, including in relation to size so that the Animal has sufficient room to stand up, turnaround and lie down without restriction; and
- I understand and accept that the transport of the Animal by air has inherent risks, including an increased risk of mortality, and that environmental conditions such as temperature and humidity levels may have a significant effect on the health and well-being of the Animal; and
- acknowledge that Qantas strongly recommends that brachycephalic animals (e.g. short-head breeds) or other animals that are prone to breathing difficulties are not lodged for transport if temperatures may exceed 20 degrees celsius at any point of the journey; and
- I acknowledge that the Animal will not be accompanied or supervised and I accept that the Airline may not have the expertise or ability to access veterinary services or identify risks to the Animal's health or well-being throughout the Animal's journey.

In full knowledge of the matters set out above, I request the Airline to:

- (1) transport the Animal/s from the origin to the destination noted below; and
- (2) arrange at my cost any veterinary services and/or assistance to the Animal/s in the case of illness, or as reasonably deemed by the Airline to be necessary for the well-being of the Animal/s during the journey.

I undertake to bear any losses, costs or expenses that may arise (directly or indirectly) in connection with:

- (1) any failure to comply with my responsibilities outlined above, including to the extent the failure contributes to any injury to or death of the Animal; and
- (2) the animal breaking out of its cage or container, including any personal injury or property damage suffered by the Airline, its personnel or any third party.

I agree that the Airline will not be liable for incidental, special or consequential damages, including but not limited to damages for emotional distress and other non-economic loss in connection with the Animal or its carriage.
